

## Grading criteria for ARKM24, Master's degree project – Classical Archaeology and Ancient History

Available grades: Fail, Pass and Pass with Distinction. For a grade of Pass, students must pass all assessment areas. For grade of Pass with Distinction, students must meet all the criteria for a grade of Pass and be awarded a grade of Pass with Distinction on at least 10 assessment areas, including assessment area 8.
